- County SPOAs that will be critical to managing referrals to the growing capacity and diverse array of children's service sector as they move from a "triage" approach to a needs based referral model
- Hospitals and Pediatric Practices that have or are going to integrate care
- Family Advocacy organizations that are seeking policy and analytical information to strengthen their message
- Community based organizations that want to stay informed about best practices, Evidence Based Practices and opportunities to collaborate on behalf of youth and families
- Substance use providers that specialize in youth and adolescent services and will need to become familiar with Home and Community Based Waiver operations
- Universities with clinical training programs and research interests in children's behavioral health care
